### Consultation Open: Draft Suicide Prevention Action Plan 2025- 2029

### Reminder of end of free RATS on 30 September 2024

- Te Whatu Ora has today <u>sent information to general practice</u>, <u>urgent care and</u> <u>pharmacies to confirm free RATs end on 30 September</u>.
- Publicly funded rapid antigen tests (RATs) remain available until 30 September 2024 for healthcare providers to access directly from the Te Whatu Ora Central Supply and the public to access through our Community Provider Distribution Channel.
- From 1 October 2024, providers will need to purchase RATs from the commercial market.

#### Public Health message in relation to Mpox

- Please see <u>this public health advisory from Te Whatu Ora, issued 11 September</u> for details of the two mpox cases confirmed in NZ linked to Winter Pride Festival in Queenstown (22 Aug – 1 Sept).
- Clinicians are asked to prioritise assessment and testing of individuals with symptoms compatible with mpox who attended Winter Pride or related events or had sexual contact with event attendees and notify their local public health service urgently of any suspected cases.

### Proposal to fund medicines for lung cancer, breast cancer, for chronic obstructive pulmonary disease (COPD), and for the prevention of RSV

- Pharmac is after <u>feedback on a proposal</u> to fund more medicines for lung cancer, breast cancer, for chronic obstructive pulmonary disease (COPD), and for the prevention of RSV.
- Consultation opens on Friday September 13 and closes on Monday October 7.

### Feedback on proposals to fund lisdexamfetamine and remove the renewal criteria for stimulant treatments

- Pharmac is now consulting publicly on a <u>proposal to fund lisdexamfetamine</u> for the treatment of ADHD and to remove the renewal criteria for stimulant treatments - methylphenidate, dexamfetamine and modafinil.

### Decision to widen access to immunotherapies for six types of cancer, and treatments to prevent fungal infections

- Pharmac has <u>decided to widen access to two immunotherapy medicines for</u> <u>cancer and two medicines for preventing fungal infections</u> in people with weakened immune systems.

## Invitation to take part in Health Information and Bundled Consent in Primary Care research

- General Practice enrolment forms require individuals to have 'read and understood the Health Information Sheet', which outlines that their health information (including patient notes, lab results and imaging) will be collected and shared with other organisations including researchers.
- Currently, service users are unable to opt out of their data being collected and (re)used if they wish to access primary care services.

- The research team are interested in the thoughts and experiences providers and experts have with the bundling of consent in general practice enrolment forms to better understand the realities and potential ethical issues of this practice.
- The invitation to participate in the research is open to those who work in primary care and are involved with collecting or accessing patient information; or those who work in an advisory, policy or leadership role in data ethics, health information and/or privacy.
